



Civil Rights Groups Condemn Department of Education Final Rule Weakening Civil Rights Protections for Students

Final Rule Would Enable Policies that Disproportionately Harm Students Based on Race, Color, and National Origin

WASHINGTON, DC (July 23, 2026) - Today 60 civil rights and education organizations issued the following joint statement condemning the U.S. Department of Education's removal of the disparate impact tool from the agency's regulation under Title VI of the *Civil Rights Act of 1964*. The groups call for the immediate reinstatement and robust enforcement of this crucial provision to protect students from systemic discrimination based on race, color, and national origin.

"Every student, no matter their background, has the right to pursue their education free from discrimination. Today's action has no basis in law or morality and is further evidence that this administration is determined to undermine our laws, abandon civil rights enforcement, and deny the existence of systemic discrimination. For decades, courts have acknowledged that discrimination is not always explicit or overt. The disparate impact tool is designed to remove unjustified barriers in education and ensure that all students have an equal opportunity to learn and succeed. Examples may include school discipline or school closure policies that appear neutral but unfairly and disproportionately harm or disadvantage Black and Native American students, as well as Latino and Asian American and Pacific

Islander students, while ignoring alternatives that better serve all students. While undermining civil rights protections is never justified, the Department's move to overhaul these anti-discrimination regulations without even providing the public with an opportunity to comment is indefensible.

The rescission will hurt Black, Latino, Asian American, and Native American students, other students of color, and other marginalized students who face higher rates of discrimination. And it will clear the way for discrimination that too often deprives students of equal educational opportunity based on race, color, and national origin. We strongly oppose the Department's rescission and urge the Department to reinstate the disparate impact tool and take seriously their legal mandate under Title VI to prevent and address racial discrimination in our schools."
